

City of Yokohama – Information About Support Benefit Due to Inflation

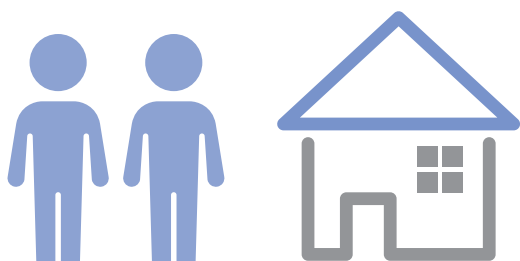
For households that are exempt from per capita resident tax for FY2024

This benefit of 30,000 yen will be paid to the heads of households that are exempt from per capita resident tax for FY2024. Out of the eligible households, those that include children born on or after April 2, 2006 will also receive an additional 20,000 yen per child.

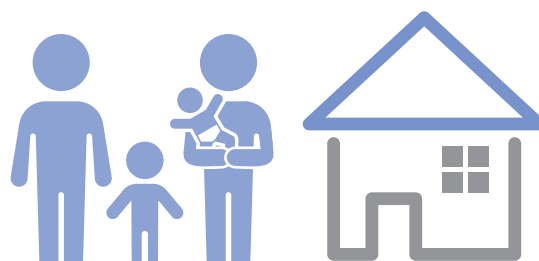
Households that are eligible for payment

- Households whose members are registered as residents of the City of Yokohama as of December 13, 2024
- Households whose members are all exempt from per capita resident tax for FY2024

Application category	Application period	Payment start date
Confirmation Letter	Applications must arrive between February 12 (Wed.) and May 30 (Fri.), 2025.	Benefits will be paid after completion of screening.

Notification of Payment	Application not required	Benefits will be paid from March 7 (Fri.), 2025.

- A **Confirmation Letter** or **Notification of Payment** will be sent by the City of Yokohama to the heads of households confirming their eligibility.
- Households that include individuals who moved to Yokohama on or after January 2, 2024, households that include individuals who have not declared their tax, and households that qualify for tax exemption after carrying out the process of revising their tax return should obtain an **Application Form** from the website or from the Application Support Desk of their local ward office and submit it during the stipulated application period.

Eligible households who have a child born between December 14 (Sat.), 2024 and May 30 (Fri.), 2025 are also eligible for this benefit. This benefit requires a separate application that must be submitted by May 30 (Fri.), 2025.

The City of Yokohama will send a **Notification of Payment** or a **Confirmation Letter** regarding newborn infants to households that have been confirmed as eligible.

Children born between December 14 (Sat.), 2024 and May 30 (Fri.), 2025 are also eligible.

Households that **need** to carry out a procedure to be paid

Households that receive a Confirmation Letter

- Households that have received benefits of 70,000 yen or 100,000 yen*1 from the City into an account belonging to someone other than the head of household
- Households that have not received benefits of 70,000 yen or 100,000 yen*1 from the City and that were registered as residents of Yokohama by January 1, 2024

 **Fill out all required information and return the Confirmation Letter together with any attached documents using the special return envelope.**

Households that must submit an Application Form


- Households that include individuals who moved to Yokohama from elsewhere between January 2 and December 13, 2024
- Households that include individuals who qualify for an exemption from per capita resident tax but who have not declared their resident tax for FY2024
- Households in which only dependents remain due to divorce from a spouse or a death in the household that occurred on or before December 13, 2024
- Households that qualify for the exemption after correcting their tax info on or after December 13, 2024

 **Download the Application Form from the website or obtain one from your local ward office and send it in by post together with all required documents.**

Households that **do not need** to carry out any procedure to be paid

Households that receive a Notification of Payment

- Households that have received benefits of 70,000 yen or 100,000 yen*1 from the City into an account belonging to the head of household

 **If there have been no changes to the information shown in the Notification of Payment, then no further action is needed. The benefit payment will be paid into the account of the head of household.**

*1 This refers to the benefit payments that were paid for FY2023 to households that are exempt from resident tax, to households that were subject to per capita resident tax-only taxation, and to benefit payments paid for FY2024 to households that had newly become resident tax exempt.

Households consisting only of dependents of individuals who are subject to per capita resident tax are not eligible for this benefit payment.

Examples of households that are not eligible

- A household consisting of a student who is dependent on a parent (who is subject to per capita resident tax), regardless of whether they live together
- A household consisting of someone who is dependent on a younger family member (who is subject to per capita resident tax), regardless of whether they live together
- A household consisting only of a person with children who is dependent on another person (who is subject to per capita resident tax) who lives at a separate address
